

Kezzler AS Privacy Policy

This privacy policy will explain how Kezzler AS (“Controller”) uses the personal data we collect from you when you use our website. Fashion360 is a joint project between Kezzler AS, Tomra AS, and Trimco Group, jointly referred to as “We”.

What data do we collect?

We collect the following personal data:

- First and Last name
- E-mail address
- Employers name
- IP address

How do we collect your data?

You directly provide us with most of the data we collect. We collect and process data when you:

- Submit contact forms on the website
- Apply to attend an event through the website

How will we use your data?

We collect your data so that we can:

- Share information about the event you have signed up for

Kezzler AS will share your data with our partner companies:

- Tomra Systems ASA
- Trimco Group

We will utilize the following services to facilitate event planning and handling, and subsequently share necessary personal data:

- Common Ninja Ltd.
- Mailchimp

How do we store your data?

Your data is stored securely in Israel and the European Union (EU). Both Israel and the EU have strong data protection laws.

We will keep your data as long as necessary to fulfill the purpose of the processing. Once this period has expired, we will delete or anonymize your data.

What are your data protection rights?

We would like to make sure you are fully aware of all of your data protection rights. Every data subject is entitled to the following:

The right to access – You have the right to request us for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Kezzler AS correct any information you believe is inaccurate. You also have the right to request Kezzler AS to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Kezzler AS erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Kezzler AS restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Kezzler AS's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Kezzler AS transfer the data that we have collected to another organization, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us at our email stated under "Contact Us" in this Privacy Policy.

Cookies

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.

We currently do not utilize cookies, but may do so in the future for e.g.:

- Keeping you signed in
- Understanding how you use our website
